By providing access to clean water-as well as sanitation and hygiene education-we are working to promote educated, healthy and economically independent communities in nine countries.

4b (Code:) (Expenses \$ 281,284 including grants of \$ 186,741) (Revenue \$) Emergency Response Here at home 2017 was a year full of natural disasters. We responded by providing essential relief to families in Texas, Florida and Puerto Rico. As well as providing them with shelter, food and essential supplies, we also provided grants to help people repair their homes and get back on their feet. Internationally, we responded to the dire humanitarian situation in Yemen and were quick to respond to the Rohingya emergency, which saw over 680,000 individuals flee their native Myanmar into bordering Bangladesh.

4c (Code:) (Expenses \$ 173,730 including grants of \$ 38,512) (Revenue \$) Domestic Programs The two main programs in the United States are Beyond Bagged Lunches and Bridging the Digital Divide. Beyond Bagged Lunches focuses on those transitioning through homelessness by providing a range of social services such as access to food, hygiene packs, winter packs and access to medical assistance. Bridging the Digital Divide seeks to help children in low income communities succeed at school by providing them with the tools they need to succeed in the 21st century. We also provide parents with computer literacy classes to help them understand their children's homework and to empower them to find employment and access social services online.
